



Objective	The Contentment Fund is established to provide the necessities of life to indigent persons who lack food and clothing and may be homeless. The activities of the fund also include sharing the gospel of Jesus Christ with such persons. The fund was created in line with 1 Timothy 6:6-8 and 1 Timothy 6:17-19	The objective of the Saints Fund is to issue capital grants to Christians who are in net debt financial positions and require help to fund their business initiatives. The fund was created pursuant to 2 Kings 4:1-7 and 2 Corinthians 9:1-5	This fund is established to support the finances of those who have been recent victims of accidents and disasters that have created health emergencies for them. The fund was created in line with Luke 10:30-37
Eligibility Criteria	Available by application to humanitarian organisations (selected countries only) engaged in providing food, clothing and shelter to indigent persons. Subject to other fund specific requirements and a formal contract.	Can be accessed by application and subject to Adullam's independent validation of the prospects of the proposed business and its compliance to God's economic system. Applicants are expected to have taken the full suite of Adullam Courses. Subject to other fund specific requirements and a formal contract.	Beneficiaries may apply or can be identified by the Fund Administration team. Subject to other fund specific requirements and validation checks.

The Adullam Funds are generated from the donations of corporate organisations and individuals. Adullam acts as a trustee of these Funds and provides services to ensure they are administered in strict compliance with their published mandates.

Transparency in the administration of the funds is achieved with the Fund Administration team drawn from seconded staff of major donors and staff of Adullam Consulting & Grant Administration Services. The governance and organisation structure for Adullam is as shown above. The Funds are managed in line with best practice fund management procedures obtainable in the development sector. Fund governance and approval for grants is provided by an Investment Committee comprising nominated representatives of the major donors. Fund administration processes have been defined to ensure adequate controls and efficiency in the application, review, selection and disbursement procedures. These processes benefit from robust monitoring and evaluation and impact evaluation frameworks.
